From the General Manager

Fiscal Year 2018 was a busy one! When you look at the next page of projects and programs accomplished and/or started in FY2018, one will notice an emphasis in infrastructure improvements. Some of those improvements were to repair existing failing components. Some of the improvements were to stay ahead of the growth curve.

Our Operations Group continues to perform at an excellent level maintaining the system. Fixing leaks, maintaining meters, collecting water samples, operating the treatment plants...it's what they do and they do it well!

Our Customer Service Group also performs at an outstanding level. They process over 100,000 transactions per year. They do a great job every single day assisting all of our 9,000+ customers on the phone or in person. They did a fantastic job converting from our legacy billing software to Xpress Bill Pay.

Compared to three years ago, our litigation issues have mostly sorted themselves out. In FY2018 the Board negotiated a net positive agreement with Pool/Pact regarding insurance claims. The Board negotiated retrieving water shares from two of three golf courses.

Staff continues to utilize the WaterWorth financial planning software to evaluate the planned cost of operations vs. planned revenue stream. Because of the current growth spurt, revenues resulting from more paying customers and from developers paying System Development Charges and Conditional Commitment for Water Service Fees continue to increase. More discussion of the financial status of the District continues further in this Report.

With our fantastic staff, excellent plans in place, and the financial wherewithal to accomplish the plans, the District is in a great place figuratively and literally!


FY2018 proved to be another eventful year as many projects were started with the aid of the new rates structure implemented in FY2015. The following projects were accomplished/started:

- Upgrade GIS System to Web Based






Well 31 Pump Replacement








Financial Report

- The 2008 Bond Was Paid Off On March 1, 2018
 - Current outstanding bond debt is \$19,728,194
 - The debt reduction surcharge dropped from \$10 to \$9.30 per EDU
- Water Use Revenue Was Up 5.3% Over The Previous Year
 - ~3% of the increase from growth in customer base
 - o ~2.3% additional growth from increase in water use and rate increase
- Total Integration of WaterWorth Software In Budget/Rate Setting Process
 - First rate increase using WaterWorth was approved in December 2017
 - o Rate increase process involves setting rates in four year increments
- Interest Income Was Up \$70,337 (70%) Over Previous Year

The District continues to be in a strong financial position, Using WaterWorth, The District has completed the first step in establishing a fully sustainable water system.

The past year the District redefined our banking relationships, which resulted in a significant increase in interest income on available cash reserves. We continue to explore ways to maximize the return on investment on our funds.
